

## **TERMS OF USE FOR PUBLIC USE FILES**

The following terms of use shall apply to all Public Use Files published on the website of the Hungarian Central Statistical Office (hereinafter referred to as: HCSO) ([www.ksh.hu](http://www.ksh.hu)).

The User of the Public Use Files acknowledges upon using the datafile the terms of use regulated in this document and their mandatory nature. The User acknowledges civil and penal liability for failing to comply with these terms.

### **Definitions:**

*Public Use File:* microdata to be accessed publicly and free of charge on the internet, where the disclosure risk of statistical units is minimal.

*Use:* downloading the Public Use Files, as well as any method or collection of methods applied to the Public Use Files, such as data capture, data systematisation, data storing, data modification, data utilisation, data transmission, data dissemination, data harmonisation, data linkage, data matching, data blocking, data deletion, data destruction.

### *User:*

Any natural or legal person or entity without legal personality, who or which is using the public use file.

1. The Public Use Files published on the HCSO website and the related metadata (hereinafter referred to as: Datafile) shall be as intellectual work owned by the HCSO based on the Act No. LXXVI. of 1999. on copyright (hereinafter referred to as Copyright Act).
2. By giving access to the Datafile, the HCSO provides a nonexclusive, not transferrable, right of use of the Datafile without any geographical or time limitations.
3. Within the right to use the Datafile the User has the right to:
  - a) copy the Datafile, to use it in a collected work with indicating the HCSO as the author;
  - b) modify, amend the Datafile, during which the amended Datafiles shall be clearly distinguished from the original Datafile upon finishing the amendment;
  - c) publish the Datafile with the exceptions defined under point 4.

4. The User shall not sell the Datafile or use it for enrichment. This limitation does not apply to the use of individual intellectual work falling under copyright based on the Copyright Act created with the use of the Datafile.
5. In cases of 3. a, c), the HCSO shall be indicated as author the following way:  
*„Source: ..... (name of the datafile) public use file prepared by the Hungarian Central Statistical Office ([www.ksh.hu](http://www.ksh.hu)).“*
6. In cases of 3. b), the HCSO shall be indicated as source the following way:  
*„This document has been created with the use of ..... (name of the Datafile) Public Use File prepared by the Hungarian Central Statistical Office ([www.ksh.hu](http://www.ksh.hu)). The calculations and the conclusion are the sole intellectual products of the Author ..... (name of the Author).“*
7. The User acknowledges that Public Use Files may only be used for strongly limited purposes. In case of use for any other purposes, the HCSO has no liability (neither expressed nor implied) for any conclusion drawn or the consequence thereof.
8. The User acknowledges that any attempt to identify the statistical units of the Datafile is prohibited and against the law.
9. The User acknowledges that
  - a) the Datafile is provided by the HCSO „as is“ and the HCSO excludes in the legally widest possible way any liability for its fitness for the given purpose;
  - b) the HCSO does not carry any liability (neither expressed nor implied) for the accuracy, reliability and content of the calculations based on the Datafile or the conclusions drawn from it, these are to be produced at the sole risk and consideration of the User;
  - c) the HCSO is not responsible for any consequence, disturbance, errors, or loss of data incurred in the computer system of the User caused by the Datafile;
  - d) based on the above, the HCSO shall in no event be liable for any direct, indirect, incidental, material, non-material damages, including but not limited to loss of profit, or reputation caused by the use of the Datafile, such as the errors of deficiencies of the calculations made, conclusion drawn from it.
10. The conditions of these terms of use are effective from the day the Datafile is made accessible and continue to have effect while the Datafile is used, except points 5-8., which stay in effect after the use is finished.
11. The rules of the Hungarian legislation shall be applied to any issues not regulated in the terms of use, with special regard to the Civil Code, the Copyright Law and the Penal Code.
