CSV file – comma separated value file format; 1 record/line XLS file – same structure in Excel format

- > 4 characters type of declaration
 - 2010 for dispatches
 - 2011 for dispatches (simplified)
 - 2012 for arrivals
 - 2013 for arrivals (simplified)
- > 2 characters reference year in the format of yy (15 for year 2015)
- > 2 characters reference month in the format of mm (e.g. 01 for January)
- > Further max. 96 optional characters
- > Extension CSV or XLS
