Upload in CSV format

In case of manual filling please ignore this chapter.

In CSV format, you must pay close attention to the leader '0',

For example, on the front page, the month of the first quarter is in two digits 03.

Attention!

If you prepare the file in Excel, the numbers must be formatted as text.

1. Select the cell or range cell range that contains the numbers to be formatted as text.
2. In the Home tab, in the Number group, click the arrow next to the Number format list and select Text.

Note: If Text is not displayed, scroll to the end of the list.
