Decree No. 16/2011 (V. 10.) of the Minister of Public Administration and Justice

on the introduction and application of the Industrial Product Classification (ITO)

By virtue of the authority granted in paragraphs *a*) and *b*) of subsection 4) of Section 26 of Act XLVI of 1993 on Statistics and acting in my capacity established in paragraph *a*) of Section 1 of Decree No. 5/2010 (XII. 23.) of the Prime Minister on the appointment of ministers supervising government offices, I hereby order the following:

Section 1 The Industrial Product Classification (hereinafter referred to as: ITO), as included in Annex 1 to this decree, shall be applied in statistical data dissemination for the purpose of classification of industrial products produced in Hungary. When disseminating data, the units of measurement listed in Annex 2 shall be applied. **Section 2** Structure of the ITO code shall be as follows:

- a) digits 1–4 correspond to the code used in the standard classification of activities (NACE Rev.2);
- b) digits 5–6 correspond to the code used in the new statistical classification of products and services (CPA);
- c) digit 8 correspond to the code used in the classification of industrial products (PRODCOM), in the case of products marked "HU" the code composed by the Hungarian Central Statistical Office (hereinafter: HCSO);
 - d) digit 9 is marked "0" in all codes;
 - e) digits 10–12 are the code indicating the unit of measurement.

Section 3 (1) This decree shall come into force on the third day following its publication in the Official Journal of Hungary.

Section 4 This decree sets provisions necessary for the implementation of
