# Rules

# of prize draw for the respondents of the research on Users of the HCSO webpage, 2019

The prize draw (hereafter draw) is organized by the Hungarian Central Statistical Office (hereafter HCSO; 1024 Budapest, Keleti Károly utca 5-7.), and is governed by these rules.

## 1. Eligibility

The prize draw is open to people who answered the online user research survey until 23:59 on 3rd July 2019, indicated that they want to take part in the prize draw accepting the present rules, and gave their e-mail address and/or phone number for notification.

HCSO's employees are excluded from participation even if all the above mentioned conditions are fulfilled.

#### 2. Prize

The winner will receive a

#### 3. Draw

Time and date of the draw: 10.00 on 9th July 2019.

Location of the draw: Hungarian Central Statistical Office, 1024 Budapest, Keleti Károly utca 5-7..

Coordination Section of the Deputy President (Dissemination Directorate), Room 103.

The draw will be performed by a random computer process. A winner and a substitute will be chosen in the draw.

The draw is organized by a prize drawing committee of 5 members employed by HCSO according to the rules set by the present document.

The draw will be performed by Mónika Freid, Deputy President of the Dissemination Directorate from the database containing the contact details of respondents participating in the draw.

The draw is public.

## 4. Receipt of the prize

HCSO will notify the winner within 1 week of the date of the draw by e-mail or telephone. The winner can receive the prize in person or at his/her request by registered postal delivery.

If the winner does not respond to notifications (by phone or via e-mail with delivery notification) in 14 days, and to second unsuccessful notification in 5 days, HCSO will notify the substitute winner drawn on the same day as the winner was drawn. If the substitute winner does not claim the prize in accordance with the process described above, HCSO retains the right to have disposal of the prize.

## 5. Tax liability and costs

Tax liabilities emerging in connection with the prize are covered by HCSO.

# 6. Data protection rules

Stating the willingness of participation in the prize draw on the filled questionnaire of "Users of the HCSO webpage" survey, accepting the present rules, giving the participant's e-mail address and/or phone number are the terms of the participation in the prize draw. Giving the winner's name and postal address and accepting that the winner's name and placename of his/her residence are published on HCSO's website are the conditions of receipt of the prize.

The present rules are regarded as information on data processing for participants in the prize draw as hereinafter:

<u>Legal basis of data processing</u>: consent of the data subject concerned to data processing according to 1. (a) in Article 6 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

<u>Purpose of data processing:</u> identifying people participating in the draw, contacting the winner, and displaying the prize draw and the winner's name and placename of his/her residence on HCSO's website to inform the public.

<u>Entitlement for data processing:</u> members of HCSO's prize drawing committee, employees of HCSO's Dissemination Directorate and Statistical Coordination and Legal Affairs Department have right to process personal data used in the prize draw, given by participants of the draw during data supply. Users of HCSO's website are able to get information on the winner's name and placename of his/her residence on HCSO's website.

<u>Data subjects and processed data</u>: participants of the draw; e-mail address or phone number given by them. In case of the winner, further data are name and postal address given by the winner for delivering the prize. Published data on HCSO's website: winner's name and placename of his/her residence.

<u>Duration of data processing:</u> HCSO deletes all personal data given by non-winner participants immediately after the draw. HCSO manages the winner's personal data until the legal liabilities

require this and until the end of the guarantee period of the prize. HCSO removes the winner's personal data published on HCSO's website on the day of the delivery of the prize or at latest on 16th August 2019.

# Exercising rights of data subject:

Participant of the prize draw can request:

- a) information on data processing of his/her personal data;
- b) to access to his/her personal data (in electronic way or by copy);
- c) to rectify incorrect and incomplete personal data;
- d) to erase his/her personal data, to restrict their processing, if the conditions of this exist;
- e) to object against processing his/her personal data.

### Redress:

In case of violating the rights of the data subject, he/she can:

- b) turn to a court (Fővárosi Törvényszék, H-1055 Budapest, Markó Street 27. http://fovarositorvenyszek.birosag.hu/english
- c) initiate an investigation by the Hungarian National Authority for Data Protection and Freedom of Information (H-1125 Budapest, Szilágyi Erzsébet Alley 22/C; <a href="mailto:ugyfelszolgalat@naih.hu">ugyfelszolgalat@naih.hu</a>) or other national authority for data protection of Member States.

#### 7. Other statements

HCSO shall not be liable for any inadequacy/error in postal address (e.g. inadequate name or address) given by the winner, delay or failure of the postal delivery caused by the aforementioned errors, and damages occurred during the delivery.

HCSO does not provide warranty of the prize. The winner can enforce these claims according to the Hungarian legislation directly towards the producer assigned by HCSO during receipt of the prize. Producer's guarantee can be enforced via the copy of the invoice which HCSO delivers to the winner at his/her request.
