Decree No. 31/2011 (X. 24.) of the Minister of Public Administration and

Justice on the territorial registration identification code system

By virtue of the authority granted in paragraphs a) and b) of subsection (4) of Section 26 of Act XLVI of 1993 on Statistics and acting in my capacity established in paragraph a) of Section 1 of Decree No. 5/2010 (XII. 23.) of the Prime Minister on the designation of ministers supervising government offices, I hereby order the following:

Section 1 The territorial registration identification code system included in Annexes 1 and 2 to this decree shall be applied for the individual identification of settlements in Hungary as well as for their grouping by statistical aspects, and for the location of settlements in statistical data collections, data processing and data supply.

Section 2 (1) The territorial registration identification code system contains the name and the territorial registration identification code of settlements.

(2)¹ The name of settlements is identical to the name supplied in the publication titled "Gazetteer of Hungary".

(3) The territorial registration identification code of settlements is made up of two parts:

a) a settlement identification number and

b) codes of grouping criteria, which are the following:

ba) county code,

bb) capital's district code,

bc) settlement's legal status code,

bd) county seat code,

be) settlement's legal status'2005 code,

bf) micro-region code,

bg) region code,

bh) statistical large region code,

bi) agglomeration code,

bj) notary district,

bk) agricultural landscape district code,

bl) grape-bearing area code,

bm) wine region code,

bn) entrepreneurial zone,

bo) tourism region code,

bp) resort area code,

bq) world heritage site code,

br) national park code,

bs) medical tourism,

bt) NUTS level code.

Section 3 (1) This decree shall come into force on the third day following promulgation.

(2) What is laid down in this decree shall first be applied in statistical data collection, data processing and data supply for the reference year 2011, completed following the coming into force of this decree.
