### **History of the classification:**

The Territorial Code System contains the all-time state of Hungarian settlements according to the current nomenclature classification. This is its 5th version since the adoption of the law in 2011.

#### **Structure:**

A territorial registration identification code is made up of two parts:

- a settlement identification number (positions 1–5),
- a series of grouping criteria (positions 6–46).

### **Short description:**

The territorial registration identification code of a settlement is made up of two parts:

- a) a settlement identification number and
- b) codes of grouping criteria, which are the following:
- ba) county code,
- bb) capital's district code,
- bc) settlement's legal status code,
- bd) county seat code,
- be) settlement's legal status' 2005 code,
- bf) statistical large region code,
- bg) region code,
- bh) NUTS code
- bi) district code,
- bj) agglomeration code,

- bk) grape-bearing area code,
- bl) wine region code,
- bm) tourism region code,
- bn) world heritage site code,
- bo) code of buffer zone of the world heritage property
- bp) beneficiary settlements code
- bq) beneficiary districts code
- br) code of free enterprise zones
- bs) code of special region from the perspective of regional development
- bt) code of the economic development zone
