# **TESZOR'15**

Full title: Hungarian Classification of Goods and Services, 2015 version

## Abbreviation: TESZOR'15 (CPA Ver.2.1)

#### Legal basis:

- Regulation (EC) No 451/2008 of the European Parliament and of the Council of 23 April 2008 establishing a new statistical classification of products by activity (CPA) and repealing Council Regulation (EEC) No 3696/93
- Commission Regulation (EU) No 1209/2014 of 29 October 2014 amending Regulation (EC) No 451/2008 of the European Parliament and of the Council establishing a new statistical classification of products by activity (CPA) and repealing Council Regulation (EEC) No 3696/93

### Implementation date: 1st January 2015.

**History of the classification:** The predecessor classification was CPA 2008, valid from the 1st January 2008 to 1st January 2015 in Hungary.

It was necessary to update CPA 2008 in order to make it relevant. First the UN Central Product Classification (CPC) and the Harmonized System (HS) have been updated, by following the economic changes. In accordance with them CPA 2008 changed, by updating classification of products and services significant in EU.

#### **Structure:**

Level 1: 21 sections identified by alphabetical codes (A to U);

Level 2: 88 divisions identified by two-digit numerical codes (01 to 99);

Level 3: 262 groups identified by three-digit numerical codes (01.1 to 99.0);

Level 4: 576 classes identified by four-digit numerical codes (01.11 to 99.00);

Level 5: 1357 categories identified by five-digit numerical codes (01.11.1 to 99.00.1);

Level 6: 3218 sub-categories identified by six-digit numerical codes (01.11.11 to 99.00.10).

## Short description:

The Hungarian Classification of Goods and Services (TESZOR'15) is identical with the European one, CPA Ver.2.1.

TESZOR is a product classification. It groups and integrates into a coherent system the outputs of activities, namely the goods and services. TESZOR classifies the products according to the criterion of economic origin, with the framework being based on TEÁOR'08 (NACE Rev.2). This means that the structure of TESZOR corresponds to TEÁOR'08 and TESZOR follows the concepts, definitions of TEÁOR'08.

Subcategories of TESZOR are defined by explanatory notes and correspondence table between TESZOR and KN.

**Main statistical applications:** National and regional accounts; input-output table (supply-use table); statistical domains and analyses requiring product data

- 1) TEÁOR'08 (NACE Rev. 2): correspondence at four-digit level (classes);
